

## Approved Identification

Primary Identification (List A) We require at least one piece of ID from this list (attested copy)	Secondary Identification (List B) ID from this section must include your name (attested copy)
<ul style="list-style-type: none"> <li>• Valid Canadian driver's license</li> <li>• Valid Canadian passport</li> <li>• Certificate of Canadian citizenship or Certification of Naturalization, in the form of a paper document but not a commemorative issue</li> <li>• Permanent Resident card or Citizenship and immigration Canada Form IMM 1000, IMM 1442, IMM 5292 or IMM 5688</li> <li>• BC Services Card. (In British Columbia, a BC Services Card may indicate it is a Services Card and a driver's license. BC residents cannot have both a BC driver's license and a BC Services Card). The BC Services Card will be considered as one piece of identification</li> <li>• Canadian birth certificate</li> <li>• An Old Age Security card issued by the Government of Canada bearing the Social Insurance Number of the person named on the card</li> <li>• Government of Canada Certificate of Indian Status</li> <li>• A provincial or territorial health insurance card, as permitted to be used for identification purposes under provincial or territorial law</li> <li>• A document or card, bearing the individual's photograph and signature, issued by any of the following authorities or their successors:             <ul style="list-style-type: none"> <li>• Insurance Corporation of British Columbia</li> <li>• Alberta Registries</li> <li>• Saskatchewan Government Insurance</li> <li>• Department of Service Nova Scotia and Municipal Relations</li> <li>• Department of Transportation and Public Works of the Province of Prince Edward Island</li> <li>• Service New Brunswick</li> <li>• Department of Government Services and Lands of the Province of Newfoundland and Labrador</li> <li>• Department of Transportation of the Northwest Territories</li> <li>• Department of Community Government and Transportation of the territory of Nunavut</li> </ul> </li> </ul>	<ul style="list-style-type: none"> <li>• Valid foreign passport</li> <li>• Bank card bearing your name and signature and issued by a member of the Canadian Payments Association (CPA)</li> <li>• Credit card bearing your name and signature and issued by a member of the CPA</li> <li>• Canadian National Institute for the Blind (CNIB) client card bearing your photograph and signature</li> </ul>

**Note:** For protection against fraud, we recommend to scratch-off the CVV number before sending credit card copies to us.

**Please Note:**

1. At least one of the identification document must be from List A above
2. One of the identification document must be a photo identification. Please ensure photo image is clearly visible. Blurry or darkened images would be rejected.
3. Identification document must be current (i.e. not expired)
4. Legible photocopy of identification document must be attested by commissioner of oaths or a guarantor after verifying with the original document.

**Acceptable Guarantors:**

- a dentist, a medical doctor or a chiropractor
- a judge, a magistrate or lawyer
- a notary (in Quebec) or a notary public
- an optometrist or a pharmacist
- an accredited public accountant (APA), a chartered accountant (CA), a certified general accountant (CGA), a certified management accountant (CMA), a public accountant (PA) or a registered public accountant (RPA)
- a professional engineer (P. Eng., in a province other than Quebec) or engineer (Eng. in Quebec)
- a veterinarian

Attestation must be in original and clearly mention the name, profession, address and signature of the commissioner of oaths or the guarantor. It should also mention the type and number of the identification document.
